2001 CIEL DU CHEVAL VINEYARD : RED MOUNTAINSOLD OUT: SORRY!

This Red Mountain wine is a wonderful blend of the finest grapes from Ciel du Cheval vineyard with just a splash of Klipsun Cabernet for mid-palate appeal.

Bottled on 6/29/03

58% Cabernet Sauvignon
(4% Klipsun)
27% Merlot
14% Cabernet Franc
1% Petit Verdot

This wine was aged in 100% new French oak barrels for 21 months; 182 cases were produced.

2001 KESTREL VIEW ESTATES VINEYARD : YAKIMA VALLEYSOLD OUT: SORRY!

The grapes for our Yakima Valley blend were sourced from the exceptional vines of Kestrel View Estates Vineyard in Prosser, but it also includes a drop of Klipsun Cabernet for mid-palate appeal and a dash of Ciel du Cheval Petit Verdot for color and flower notes.

Bottled on 6/28/03

67% Cabernet Sauvignon
(4% Klipsun)
16% Merlot
16% Cabernet Franc
1% Petit Verdot
(Ciel du Cheval)

This wine was aged in 84% new French oak barrels for 21 months; 156 cases + 6 bottles were produced.

2001 MISCELA (Italian for "blend")SOLD OUT: SORRY!

Our 3rd wine...and only with respect to this list and surely not in quality...is a blend from Conner Lee Vineyard, Chandlers Reach Vineyard, and Kestrel View Estates, but also includes a touch of Klipsun Cabernet for softness and a splash of Ciel du Cheval Petit Verdot for color and aroma.

Bottled on 6/22/03

49% Merlot
(33% Chandler Reach, 16% Kestrel)
34% Cabernet Sauvignon
(25% Conner Lee, 6% Klipsun, 3% Kestrel)
16% Cabernet Franc
(15% Kestrel, 1% Ciel)
1% Petit Verdot
(Ciel)

This wine was aged in 75% new French oak barrels for 21 months; 165 cases were produced.
